A Bill of Complaint was brought by Humfrey Robynson of Nedeham Grange, Sir Robert's assign, against Thomas Benet and Oliver Rogers and others who had broken down the hedges, saying that the land was common land of the lordship of Hartington; an investigating Commission was appointed by the Court, Sir Philip Draycott head; Robynson submitted a Bill of Particulars: an extract from the Coucherbook of the Honour of Tutbury, attested by Thomas Burgoyne, esq., auditor.
