EXPLANATION:

Spencer Library has an outstanding collection of the publications of Edmund Curll (1675-1747), a publisher satirized by Pope as "The Unspeakable Curll" for his underhanded ways. Curll produced hundreds of books, almost all bibliographical conundrums; an unsatisfactory bio-bibliography by Ralph Straus was published in 1928. The core of the "Curll Collection" was bought from Peter Murray Hill in 1955, since when it has grown to ca. 800 titles. In 1960 [?] the "Curll Committee" (a group of English Department faculty) began to work on a replacement for Straus based on the KU holdings, and in 1961 received a University grant for the Project which continued until 1964. The principal and continuing investigator was Professor Edward Ruhe, assisted by the librarian Terrence Williams.

By 1965 Ruhe had prepared a fairly full typed list of all Curll publications 1706-1714, based on KU holdings, visits to libraries in the US and England, publishers' ads, etc. This list is arranged chronologically by apparent date of imprint, and includes data not in Straus, and titles for which no physical book has been found. It does not give collations, but does transcribe titles and narrate publication history. Ruhe's list is in a preliminary form, and some accompanying notes are not integrated into it. It was never used for a public description: most books in the Curll Collection are represented in the card catalogue only by brief cards.

Ruhe appears to have worked little on the Project after 1965. He died in 1989, and his papers were forwarded by Fred Whitehead (of Kansas City, Kansas) to the University Archives in spring 1991. There material concerning the Curll Project was sorted out- and sent to the Department of Special Collections to be used with the Curll Collection. (There may still be relevant material in the Archives, because the labels of the folders in which the papers in hand were kept seem not always to reflect actual contents.) The location of the worksheets is unknown. Some material in the Department's own files arising from the Project has now been added to Ruhe's files.

OTHER NOTES:

1. Three apparently non-Curll-related photostats were found in this group and returned to University Archives. They made up a poor and incomplete copy of Public Record Office C12/12:4/66. "C12" = Chancery Proceedings: Six Clerks Series: 1758-1800 section. Bills, answers, depositions, etc.

(Before 1842 the "Six Clerks" were virtually the solicitors acting for the plaintiffs or defendants in each Chancery suit. A "bill" here is a petition initiating an action in the Chancery Court. An "answer" was annexed by the defendant's "Six Clerk"; but later answers were filed elsewhere. The Six Clerks Series had not been calendared in Lists and Indexes by 1963. See Handbook of the Public Record Office.)

The document is a petition, apparently by Jacob Tonson and Richard Tonson (Milton's publishers), who had become possessed of the original manuscript of Paradise Lost, the Life of John Milton, and the Index or Table of Contents written by Elijah Fenton, through the will of Jacob Tonson [II] who d. 1735; they appear to be bringing a suit for infringement of copyright. The photostats are fairly illegible, and the name of the defendant is not obvious to the skimmer. From the dates of Jacob I, Jacob III, and Richard the petition must be dated between 1735 and 1767; if it is filed in the correct section it should be after 1758, and thus too late for Curll to be directly involved.

2. Note also C1054 in printed books: the Straus handlist interleaved (apparently by Straus) with notes, corrections, and printed descriptions of many titles "not in Straus" -- these notes apparently partly by Straus (who d. in 1950), and partly by others, including Peter Murray Hill. C1054 was acquired in 1960 from the Frank Hollings Bookshop, cat. 264. (Photocopy of Hollings description in MS Records.)
