CONSERVATION:

We unfolded most items partially, so that each could still fit in a legal folder. Particularly fragile items (21, 46, 49, 65, 83, 86, 95) were fully unfolded and encapsulated in mylar; an experimental seal-box was made for the delicate fragmentary seal on item 42 and a pocket made on its folder for a detached fragment; the folder for item 46 was given an experimental padded covering to protect its (unimportant) seal. [done by WL Mitchell Sept 1989]. Each box contains a warning sheet about seal-handling; a dummy is left for each item removed to oversize.
