[Identifications by the booksellers Sotheby's.] Probably most are semi-official governmental productions, caused by the necessity to get James' finances on a solid footing.

Recipients include the "King's two daughters", Lord Danvers, the Queen's jointure: James' 2nd daughter, Margaret, was b. 1598 and died as an infant; James' 3rd daughter, Mary was b. 1605, d. 1607; Danby was known as Danvers 1603-1626; James' Queen d. 1619. Charles I had no children before 1630. I cannot find another Lord Danvers. Therefore I believe the King is James I; and if Margaret was dead by 1603, this budget was probably made up during Mary's life (1605-1607). These are the years when James was trying to come to an agreement with Parliament on the sources of his income -- the Crown was not only deeply in debt but incurring an annual deficit of ca £50,000: note the last entry in this MS "And soe the ordinary Chardge and paymte doe exceed the ordinarye Receptes yerely the Somme of £48650/8/1 3/4". (The failure of James' projected "Great Contract" led in the long run to the Civil War.) From 1599 to 1608 the Lord High Treasurer was Sir Thomas Sackville (1st lord Buckhurst &

DATING: No dates are given rexcept for a mention of 40 Eliz (1598). The sums are averages "one year with another" "during the space of 4 years". Superficial research seems to disclose that Wallop and Quarles died in 1599, and that Peyton was Lieutenant of the Tower from 1597 to 30 July 1603. The King is mentioned throughout, but sometimes over an erasure; James came to the throne 24 March 1603. It would seem, then, that this budget was prepared for the new King, using statistics from Elizabeth's reign; the scribe was used to writing "the Queen's Majesty" and sometimes did so by mistake.

Thomas Sackville, 1st Earl of Dorset and Baron Buckhurst, 1536-1608, became Lord Treasurer in 1599 and "performed his duties with business-like precision". He was reappointed Lord Treasurer by James on 17 Apr 1603, and made Earl of Dorset on 13 Mar 1604. He died 19 Apr 1608. He is well-known as a poet, and there are numerous

letters and state-papers extant in his handwriting. (See DNB).

Sir Julius Caesar, 1558-1636, rose quickly under Elizabeth to responsible administrative positions in law, London, church, government, etc. Judge of Admiralty Court, Master of Chancery, M.P., Master of requests... Knighted by James 20 May 1603. Made Chancellor and under-treasurer of the Exchequer 7 Apr 1606-1 Oct 1614. This "coincided with the period of Salisbury's treasurership, the period during which James's financial difficulties and the consequent tension between him and the Parliament reached their extreme point. He seems to have been really little better than a clerk to the lord treasurer..."

As such, employed estimating (in connection with the Great Contract of 1610) conversion of knights service, abolition of wardships, etc. Became Master of the Rolls.

Last task was to correct abuses in the Chancery. "A multitude of misc. papers in his handwriting will be found in the Lansdowne and Add. MSS in BM, his library having been dispersed on the sale of the family estate at Bennington in 1744." He wrote "The auncient state authoritie and proceedings of the Court of Requests", 1597; a dialogue advising the Commons to accept the Great Contract (Parl. Deb. 1610, App. D); "Concerning the Private cPrivy: Council...", 1625 (Cal. State Papers, Dom 1625-6, p. 138); 2 papers on Prince Henry (Archaeologia XII 82-6, XV 15-26). (See DNB)

CSalisbury (Robert Cecil, 1st earl of Salisbury, 1563-1612) ran the country for James, and succeeded Sackville as Lord treasurer 6 May 1608. After his death the

Treasury was run by a commission.]

PROVENANCE:

These papers are in many different hands. Most are docketed with a Roman numeral in red; but there are gaps in the series and the arrangement is not helpful. Most bear foliations indicating that they were previously (18th cent?) bound together in a volume or volumes; again there are gaps and the arrangement is unhelpful. There are also docketing appears on most, usually transcribed in a later (18th-19th cent?) hand. The later hands often transcribe internal titles and sums of money as well.

Apparently, then, Caesar collected these papers, someone bound them together, and someone disbound them. Losses and interlopers probably occurred at each stage.

WARNING: Item 48 is certainly an interloper. It is (contemporary?) notes concerning the commission investigating Walpole's administration in 1742.
