But in December Bartholomew Gillman, John Fowke, Richard Chambers, John Rolles, marchants of London plotted with Richard Phillips and other servants of the Sheriff [f. 283r] to hinder taking customs, and to land their goods elsewhere, and to raise tumult and sedition. On 5 Jan 1629 Gillman etc raised a riot against the Custom House Quay [details] [f. 286r] Therefore I request subpoenas [?] against Gillman, etc. to appear before the Star Chamber. "... fitt And yo' highnes said Attorney shall ev' pray for yo' ma'tie."
